For all orders submitted on this 2012–2013 Flu Purchase Pre-book Form, Customer shall receive the following benefits:

- Delivery by October 15, 2012.
- Customers who order 300 or more doses (30 units in any combination of vials or boxes of syringes) on or before August 1, 2012, shall have the right to return up to 20% of unopened product for replacement product the following influenza season according to these guidelines:
  - Units (vials or full boxes of PFS) must be returned to CFA Medical on or before March 31, 2013 and in accordance w/ Novartis Vaccines' instructions
  - Only complete units (vials or full boxes of PFS) are eligible to be returned
  - Replacement product can only be issued in full vials or boxes of pre-filled syringes, and eligible quantities will be rounded down to the nearest increment of five; For example:
    - A purchase of 30 vials = 6 vials eligible for return;
    - A purchase of 33 vials = 6 vials eligible for return;
    - A purchase of 35 vials = 7 vials eligible for return;
  - Customer shall receive an equal number of replacement units in the subsequent influenza season

Due to the uncertain nature of future supplies, we cannot guarantee that a particular amount of vaccine will be shipped. Pre-books become confirmed orders as of August 2, 2012, at which time they cannot be cancelled, terminated, reduced or returned, except as stated in #2 above. Flu vaccine is a NON-RETURNABLE product except as outlined above.
